#### Informational Text on the Protection of Personal Data Related to Cookies

(The "company") as of We have www.remakreduktor.com.tr) our website (the "website") when you visit our web site to enhance the user experience on our website, in order to ensure the efficient operation of our services and get the most out of your personal data is processed by our company are being used and through this to some cookies.

The Law on the Protection of Personal Data No. 6698 (Personal Data Protection Law) and other relevant legislation determines some procedures to be followed by the persons concerned regarding the processing of personal data. Pursuant to the Personal Data Protection Law and other relevant legislation, our Company, as the data controller, has an obligation to inform you about the processing of your personal data and to obtain your express consent in some cases.

This information text has been prepared to inform you about the cookies used when you visit our website, some of your personal data processed by this means and the processing of your personal data.

## 1. Your Personal Data Processed Through Cookies:

"Personal data" is your information that can help our company directly or indirectly identify you.

In this context, when you visit our website, marketing information such as cookie records, which are general personal data, exit IP address information, visit records / date and time of our website, route records, destination IP address information, and computer serial number / information when you visit our website via computer. When you visit our website via your mac ID, mobile phone, your transaction security information such as mobile phone serial number / IMEI number, requested URL or file, status / status information such as error messages are processed.

## 2- Description of Cookies:

Cookies are very small text files, usually consisting of letters and numbers, that are saved on your computer by the websites you visit through browsers. Cookies are created by the servers that manage the website you are visiting. This way, when a visitor visits the same site, the server can understand this and the website will open faster.

In addition to the mandatory cookies necessary for the operation of the website, our Company may also use some non-essential cookies. Our company uses these cookies not to track or identify visitors, but to obtain useful information about how the sites are used in order to continue to improve our sites / services for our visitors. Our provision of the service we provide is realized only thanks to the information we obtain from the systems that use these cookies.

### 3- Types of Cookies:

### a. Types of Cookies in Terms of Use:

Compulsory Cookies:	These cookies are absolutely necessary for the website to function properly. These cookies are needed to manage the system and prevent fraudulent transactions, and if they are blocked, the website will not be able to function properly.	
Function Cookies:	These cookies are used to give you a more advanced and easier user experience. They perform functions such as remembering your previous preferences and allowing you to easily access some content on the website.	
Analysis/Performance Cookies:	These cookies are; It is the data that enables us to analyze and understand the functioning of the website and see which of our pages attract more attention, which resources are viewed more, and then see	

	the traffic on our sites and provide a suitable service for this traffic. This information is stored anonymously by the cookie.	
Targeting/Advertising Cookies:	These cookies are used to identify and serve you content that may be of interest to you, including advertising content.	

# b. Types of Cookies in Terms of Storage Period:

Persistent Cookies:	These are cookies that persist on a person's computer until a certain date or until they are deleted by the user. These cookies are mostly used to measure users' site movements and preferences.	
Session Cookies:	These are the cookies that are created when you visit a website and are used during your visit and are valid until the browser window is closed. Such cookies do not collect data from the user. Purposes; To ensure the continuity and security of your visit, and to help third parties to provide services, especially advertising services, on the website and to increase the effectiveness of these services.	

## 4- Cookies Used on Our Website:

# a. Mandatory Cookies Processed by Our Company:

These cookies are absolutely necessary for the website to work properly, and if it is blocked, the website will not be able to function properly. This category includes only cookies that provide basic functionality and security features of the website.

Advertising cookies, on the other hand, are used to identify and serve you content that may be of interest to you, including advertising content.

These cookies are used, processed and kept by Google only with your express assent.

- Carrying out advertising activities and marketing analysis studies (legal reason: "explicit consent
  of the data owner / visitor") and in this context; Analyzing our website and increasing the
  performance of our website, for example determining the number of visitors to our website,
  adjusting performance accordingly, or making it easier for visitors to find what they are looking
  for,
- Increasing the functionality of our website and providing ease of use, for example, remembering search queries in the next visit of our website visitors,
- To improve our website, to offer new features on our website and to personalize the offered features according to your preferences,
- Targeting and advertising activities are processed within the scope of Personal Data Protection Law and other relevant legislation in order to display advertisements related to the relevant areas of the visitors, for example, on the pages and products viewed by the visitors.

# 6- Legal Reasons for Processing Personal Data Processed Through Cookies and Collection Method:

Your personal data that we process through mandatory cookies is based on the legal reason that "data processing is mandatory for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject", and your personal data that is

processed through analysis / performance / advertising cookies is only possible if you give your "explicit consent". Within the scope of your visit to our site, it is collected and processed in electronic media by automatic means through cookies.

## 7- Where Personal Data Processed Through Cookies Is Transferred To:

Your collected and processed personal data is transferred to the information technology service provider / supplier for the purpose of obtaining information technology services related to the website and to authorized public institutions in order to fulfill our legal obligations.

Regarding analytics/performance/advertising cookies, our Company also owns Google, Inc. It uses Google Analytics, a web analytics service provided by ("Google"). In order for our company to receive these services from Google, the cookies in question and your personal data processed through cookies are transferred to Google and will be stored in Google's data centers abroad.
